



## RELEASE OF LIABILITY

**1. AGREEMENT TO FOLLOW DIRECTIONS.** I agree to observe and obey all rules and warnings, and further agree to follow any oral instructions or directions given by Lonestar Fowl Boys, or the employees, representatives or agents of Lonestar Fowl Boys.

**2. ASSUMPTION OF THE RISKS AND RELEASE.** I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge the landowner where the hunting may occur, Lonestar Fowl Boys and their respective family members, employees and other parties, for injury, loss or damage arising out of my or my family's use of or presence upon the facilities of Lonestar Fowl Boys, whether caused by the fault of myself, my family, the landowner where the hunting may occur, Lonestar Fowl Boys and their respective family members, employees and other parties, or other third parties, regardless of any negligence or other fault on any of those parties part.

**3. INDEMNIFICATION.** I agree to indemnify and defend Lonestar Fowl Boys against all claims, causes of action, damages, judgments, costs or expenses, including legal fees and other litigation costs, which may in any way arise from my or my family's use of a presence upon the facilities of Lonestar Fowl Boys.

**4. FEES.** I agree to pay for all damages to the facilities of Lonestar Fowl Boys caused by any negligent, reckless, or willful actions by me or my family.

**8. ENFORCEABILITY.** The invalidity or unenforceability of any provision of this Agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the validity or enforceability of any other provision of the Agreement or of any other applications of such provision, as the case may be, and such invalid or unenforceable provision shall be deemed not to be a part of this Agreement.

**9. DISPUTE RESOLUTION.** The parties will attempt to resolve any dispute arising out of or relating to this Agreement through friendly negotiations amongst the parties. If the matter is not resolved by negotiation, the parties will resolve the dispute using the below Alternative Dispute Resolution (ADR) procedure.

Any controversies or disputes arising out of or relating to this Agreement will be submitted to mediation in accordance with any statutory rules of mediation. If mediation does not successfully resolve the dispute, then the parties may proceed to seek an alternative form of resolution in accordance with any other rights and remedies afforded to them by law.
